

CURRENT BUDGET

\$136,500

The library's operating budget has declined or remained the same for the past several years. Recent budgets have had to cover the cost of increased expenses including \$16,000 for library rechartering. In addition, mandatory NYS minimum wage requirements significantly impacted payroll.

NOTE: The 2022 budget includes expenses for the re-charter of the library.



SITUATION

The library continues to experience decreasing income and increasing expenses, while continuing to provide the community with quality programs, services and library materials.



DECISION

After consideration over the past few years, the Board of Trustees passed a resolution to transition from a Municipal Library to a "School District Public Library" that would be funded solely by a voter approved budget.

WHAT IS A SCHOOL DISTRICT PUBLIC LIBRARY?

New York State Education Law- Section 255, 259 (1)(a), 260

- School District collects tax money for library and turns it over to library Board.
- School District would have <u>no</u>
 <u>involvement</u> in operations of the library.

WHAT IS A SCHOOL DISTRICT PUBLIC LIBRARY?

... Continued

- Libraries can secure funding through a district-wide public vote on a budget.
- If approved, library would revise Charter to be a school district public library.
- Trustees would be <u>elected</u>.

MORE ABOUT A SCHOOL DISTRICT PUBLIC LIBRARY

- Coverage area geographical service area that serves the entire school district.
- Elected Board of Trustees which provides representation for taxpayers.
- Have secure and reliable funding for library building, utilities, materials, personnel, programs and Nioga services.

BOARD OF TRUSTEES

- Presented a formal written funding proposition to the Oakfield-Alabama Board of Education for the voters to vote upon.
- ▶ Developed plan to share vote information with school district residents.
- ▶ Continue to share information on our website, in the local news, at one-on-one sessions at library on Thursday, April 13 from 7-8 PM and Saturday, April 15 from 11 AM 12 PM.

HAXTON MEMORIAL LIBRARY PROPOSED AMOUNT FOR PUBLIC VOTE



NOTE: Any future increase to this amount would have to be approved by the taxpayers in another separate vote and would be subject to the tax cap law.



2023 BUDGET TO COVER:


- Personnel part-time Library Manager, 2 parttime Clerks
- 10 Additional Hours of Operation from 25 to 35 weekly as mandated by NYS DLD
- <u>Ability to purchase materials</u> books, periodicals, DVDs, music CDs, computer software, etc. which we have not been able to afford
- Ability to offer expanded programming



PROPOSED BUDGET TO COVER: continued

- The library's chartered service area would include patrons in the Oakfield-Alabama Central School District.
- Ability to keep up with <u>new technological</u> <u>programs and equipment</u> – computers and software.
- Library upkeep, utilities, maintenance

PROPOSED BUDGET BREAKDOWN



PROPOSED LIBRARY BUDGET

The tax levy - approximately \$.57 per thousand of assessed property valuation.

For example, the approved budget would cost the average taxpayer with \$100,000 assessed value property approximately \$57 annually.

COMMUNITY-BASED FUNDING OF LIBRARY BUDGET WOULD:

- ▶ The library would no longer have to rely on discretionary funding
- Remain a separate line item on Oakfield-Alabama Central School District tax bill for the library budget amount
- ▶ Allow for additional hours of operation (from 25 to 35 per week)
- ▶ Allow for an increase in children and adult programming
- Allow for scheduled library maintenance
- Allow for a greater selection of library materials books, DVDs, periodicals, music CDs, computer upgrades, computer software, etc.
- Taxpayer representation on Board of Trustees Board members are elected
